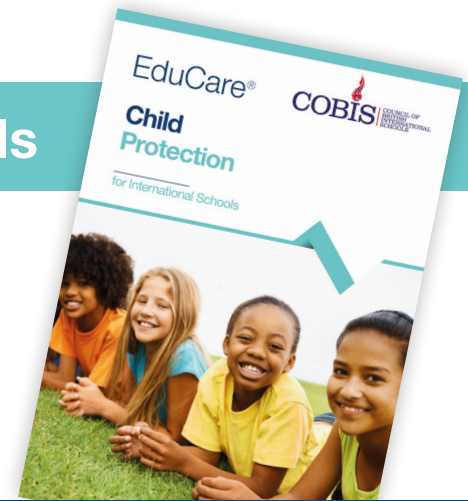


## Child Protection for International Schools

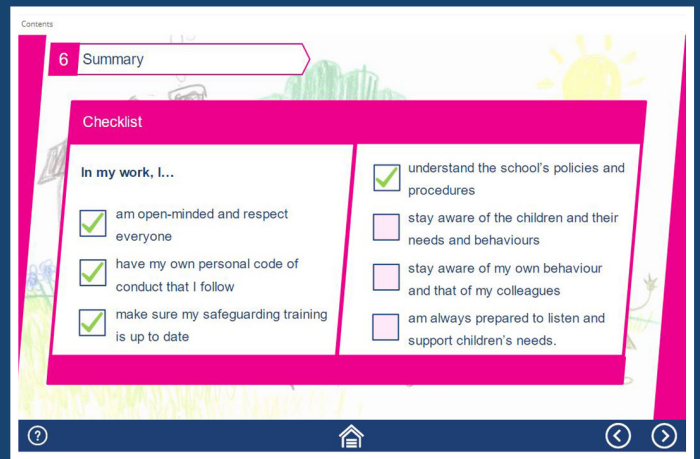
