- How you promote your expectations for behaviour and attitude.
- What the inspector will consider for this judgement.

Personal development

- What you can do to support the personal development of the children in your setting.
- British values, including democracy, the rule of law, individual liberty and mutual respect.
- What the inspector will consider for this judgement.

Leadership and management

- How well managers monitor the quality of everything that happens in the setting.
- What the inspector will consider for this judgement, and how to prepare for it.

Overall effectiveness

 How the inspector reaches their judgement for overall effectiveness.




