


The Importance of Self-Evaluation

What is self-evaluation?

Self-evaluation, also referred to as self-assessment is described by Collins Dictionary as:

"the process or an instance of assessing oneself and weighing up one's achievements"

In an early years context this means the provider's assessment of their effectiveness against the criteria used by Ofsted when they inspect a setting. It is particularly important that a provider is also using assessment of their provision to reach a judgment, just as Ofsted will, as to whether they are currently outstanding, good, requires improvement, or are inadequate in each area.

The key elements of self-evaluation

Self-evaluation is not:

- a list of what you do in your setting
- a one-off event, it should always be work in progress
- burdensome - if it is being used effectively
- one person's job to complete.
