

## Safeguarding Children in Health & Social Care

Safeguarding is everyone's responsibility, so all staff working in a health or social care setting need to ensure that children are protected from harm. This programme will help give participants confidence that they understand the different forms of abuse, are able to recognise them and take action should there be concerns about a child or young person's wellbeing. This programme has been mapped to the Care Certificate and CSTF for health.

### Programme objectives

7. Covers safeguarding legislation and good practice.

- How to report abuse and share information
- What typically happens after concerns have been reported

### 5. Safeguarding Legislation and Good Practice

- What legislation and guidance exists to help protect the welfare of children and young people
- What organisations can do to foster and promote a culture of safety.
